CHIEF'S September 2016 REPORT TO THE BOARD

Calls for Service **DO NOT** include:

- Community Service events, meetings, school visits, drop in visits, or lectures
- Foot Patrol in high visibility areas
- Pedestrian interactions
- Parking tickets issued
- **Some** miscellaneous provincial statute charges

During the month of September 2016, the Midland Police generated 754 incident reports in response to community needs. This is up from 722 incidents during the same time period in 2015. Incident reports generated to date for 2016 stand at 6617 as compared to 6012 for 2015.

CRIMINAL OFFENCES

Theft Under \$5,000

There were (25) thefts reported to the Midland Police Service in the month of September. Of the (25) thefts reported, (5) were cleared through investigation or charges, and (3) were cleared by discretion/diversion and the balance are under investigation.

(28%) of these thefts were from un-locked vehicles.

The clearance rate for thefts this month is (32%).

Mischief

There were (11) mischiefs reported to the Service this month. All are currently under investigation.

Break and Enter

A total of (10) break and enters were reported to the Service in September. All (10) are under investigation.

Fraud

A total of (2) frauds were reported to the Service in September. Both cases are under investigation.

Assault

There were (2) assaults reported to the Service in the month of September. (1) was cleared through investigation or charge and the other is under investigation.

Criminal Harassment/Threats

There were (6) harassment complaints in the month of September. (5) were cleared through discretion/diversion and the remaining matter is under investigation.

Clearance rate (83%)

A total of (6) threatening cases were reported to the Midland Police Service during the month of September. The Service cleared (3) through investigation/charge and (3) were cleared through discretion/diversion.

Clearance rate (100%)

Discretion/Diversions/Alternative Measures – YCJA/Other:

There were (11) criminal matters diverted/alternative measures in the month of September.

VCARS Referrals:

There were (7) referrals to the Victim Crisis and Referral Service in the month of September.

RIDE/Foot Patrol:

During the month of September, Midland officers conducted a total of (48) hours of RIDE. A total of (1500) vehicles were stopped by Midland officers this month. A total of (14) traffic cautions were issued. No impaired drivers were detected by officers.

In addition, a total of (93) hours of foot patrol was conducted in our high visibility locations, including the downtown area, Rotary Trail, NSSRC and others.

Impaired Driving

There were (1) impaired driving charges laid this month.

Drug Charges

There were (2) drug charges laid this month and two people arrested for those charges.

Mutual Aid between MPS and OPP

MPS to OPP: (1.5) hours - Led Law Enforcement Torch Run through Penetanguishene.

OPP to MPS: (20) mins – Assist at an alarm call – MPS officers on priority call.

Auxiliary Hours

(122) hours of service which included; general patrol with uniformed officers and foot patrol.
